#### Reasons for getting a refund

- 1 Drop a class before add/drop period is over
- 2 Resign from the University before Census Day (partial)
- 3 Overpayment from loans or grants
- Ways to get a refund
  - Refund based on method of payment (NO REFUNDS ARE ISSUED IN THE OFFICE) Credit card
  - Check takes approximately 3-5 days longer than direct deposit
  - Direct Deposit (directions to setup on our website bursar.louisiana.edu) Safer





# REFUNDS

- Negative balance on the account
  - Due to:
    - Dropped class (if before add/drop day)
    - Overpayment from Fin Aid/Scholarships
- Estimated Aid must come in before refunded
  Begin refunding 1<sup>st</sup> day of classes



- Direct Deposit Recommended
- Check in the mail
  - Sent to mailing address in system
  - Change mailing address if move
    - Registrar's Office
- Credit to your card
  - If paid via credit card



- Direct Deposit Form (packet/website/office)
- Voided check or letter from your bank
  - Cannot be temporary check
  - Bank account must be in student's name
- Submit via email (from University email), mail, or in person
